ALL CONTESTANTS MUST BE REGISTERED & CONFIRMED VIA EMAIL BY 11/16/25. YOU MUST BE CHECKED IN AT THE CONTEST TENT NO LATER THAN 15 MINUTES PRIOR TO THE CONTEST START TIME ON THE DAY OF THE EVENT (11/23/25). **THIS TENT IS NEXT TO THE MAIN STAGE.**

THE PERSON WHO IS FIRST TO FINISH THEIR WHOLE PIE IS THE WINNER.

CONTESTANTS MAY NOT TOUCH ANY OF THE PIE UNTIL THE START SIGNAL IS GIVEN.

LARGE PIES ARE USED IN THE GROWN UP DIVISION & SMALL PIES ARE USED IN THE KIDS DIVISION

PARTICIPANTS MUST KEEP THEIR HANDS BEHIND THEIR BACK AT ALL TIMES DURING THE CONTEST.

CONTESTANTS CAN USE THEIR HANDS TO DRINK WATER DURING THE CONTEST BUT MUST RETURN THEM BEHIND THEIR BACK WHILE EATING THE PIE.

VOMITING DURING A CONTEST IS AN AUTOMATIC DISQUALIFICATION.

PARTICIPANTS MAY NOT SPIT OUT FOOD IN ORDER TO MAKE ROOM FOR MORE PIE IN THEIR MOUTHS.

PUSHING TOO MUCH FOOD ON THE FLOOR OR LAP DURING OR AT THE END OF THE COMPETITION IS NOT ALLOWED.
